## PAYNOW Corporate X Crants

**Benefits** of registering your corporate bank account with PayNow Corporate:

- <u>Receive grant disbursements</u> from Singapore Government Agencies e.g. CMF by linking your Unique Entity Number (UEN) to your relevant bank account.
- 2. Grantees on OurSG Grant Portal <u>no longer need to submit GIRO form</u> to CMF and NAC, to allow your bank account number and details to remain private.
- 3. You will be **notified of disbursements** to your bank, subject to the notification settings you have registered with your bank.
- 4. Over 6 Million registrations nation-wide, with PayNow Corporate **provided by 15 participating banks\*.**


#### PayNow Corporate for OSG: to register suffix with "CMF"



- 1. From CMF2023, Cultural Matching Fund and grants on OurSG Grant Portal will be progressively moved to PayNow for disbursements.
- 2. To receive your disbursements, CMF recipients will need to set-up PayNow Corporate to your dedicated CMF bank account.
- 3. CMF recipient will need to register their UEN and 3 characters suffix, via their internet banking applications as illustrated below :

E.g. ABC Art Organisation	PayNow Proxy + 3 Suffix
Operating Bank Account	201450123WOPS
Dedicated CMF bank account	201450123WCMF

- 2. To reinforce on IRAS's sharing, if in doubt, please check with Sector Administrator if the agreement qualify for tax deductions through qualifying cash donations.
- 3. We would like to remind that only qualifying cash donations will be matched by CMF, and declarations will be required during your CMF Application on OurSG Portal:

I/We certify that the cash donations submitted to CMF are Qualifying donations in cash. "Qualifying donations in cash" means: (a) if the recipient is an "Institution of a Public Character" as defined in the Charities Act 1994, cash donations made to the recipient within the Relevant Period which qualify for concessionary income tax treatment by the Inland Revenue Authority of Singapore; and (b) if the recipient is a registered charity in Singapore, but is not an "Institution of Public Character", cash donations made to the recipient within the Relevant Period which would have qualified for concessionary income tax treatment by the Inland Revenue Authority of Singapore had the recipient been an "Institution of Public Character" as defined in the Charities Act 1994. Relevant receipts and supporting documents are properly kept and will be produced upon request by the CMF Trustees or its appointed officers.

# Timely usage of grants within 3-year utilisation period and submission of Milestone Reports by 30 Apr 2024



From the Application window 2018:

- 1. All CMF approved grants from 2018 are subjected to the 3-year utilisation period as per clause 3.7 of the Deed of Acceptance.
- CMF has streamlined the utilisation deadline of the respective CMF grants to the end of the Financial Year (e.g. CMF Deed of Acceptance signed for CMF2020 to be fully utilized by <u>31 March 2024</u>)


We would also like to remind of timely milestone report submission as follow:

2018, 2019, 2020, 2021 and 2022	1 April 2023 to 31 March 2024	30 April 2024
2023	1 June 2023 to 31 March 2024
